**GROWN RENTAL AGREEMENT**

1. Your complete gown rental includes
  - A. Gown
  - B. Alterations
  - C. Steaming and pressing services
  - D. Cleaning services
2. Accessories- (veils, tiara etc.) and or shoes can be ordered and are for purchase ONLY.
3. Rental reservations placed within 1 week or less prior to the event date is considered rush order and will incur an additional fee \$40 plus tax.
4. Once the rental reservation is made, the credit card submitted with the rental gown order from will be automatically charged for the full rental cost plus the security deposit.
5. The security deposit will be returned once the dress and accessories are returned in the same condition you received it.
6. Rental returns are expected at the exact date and time we have agreed upon. There will be a \$30.00 charge per day for late returns. If date falls on Sunday, return on Monday before 6:00pm. Else late fee will start to apply.
7. Renter agrees that the garment rented will used in the manner for which it was reserved for. And will return the gown in the original garment bag it was received. Renter is responsible for any repairs or replacement costs if gown is damaged or lost.
8. Renter is responsible for the rented gown to the clothing boutique at 892C MAIN STREET, Worcester MA 01610.
9. Rental cancellations must be made no less than 1 weeks prior to the event or date scheduled. If cancellation is made within time mentioned above, the renter will be charged 50% of rental cost.
